CONDITION OF TENDER AND INSTRUCTION TO TENDERERS

INSTRUCTION TO BIDDERS

1) Scope of Work:

- 1. Supply of Internet lease line to PMC head office for three years.
- 2. All hardware required for all data links would be supplied by the vendor.
- 3. 99% up time of the links should be ensured by the vendor.
- 4. The bidder is expected to submit a quarterly performance report on status of all links at time of bill submission.
- 5. Commissioning & Implementation of IT Infrastructure Internet Lease line connectivity.
- 6. Maintain the Project Facilities installed in the Project Area.
- 7. Supply and replacement of all defective parts/ components of the Project Facilities.
- 8. Bear all cost of Maintenance of the Project Facilities.
- 9. 24x7 round the clock support should be available through phone helpline.
- 10. Provide 10 Nos. of 4 G Internet WIFI devices with 4G data pack.
- 11. Provide Desktop/ Mobile version for Link monitoring all ILL.
- 12. Also, if services are not found satisfactory, PMC reserves the right to cancel the contract with one-month notice.
- 13. Internet Router Port at ISP Gateway for required bandwidth and minimum 8 Public IP addresses of ipv4 pool and 8 Public IP addresses of ipv6 pool including Reverse Lookups configured at these IP's.
- 14. Installation, Commissioning, Configuring of the link and hardware (Modems, Router Firewall etc. to make line fully functional at 100 Mbps).
- 15. Maintenance support service (24/7 in three year) for Bandwidth and Equipment.
- 16. The bidder have to deposit 5% security deposit amount of total contract value.
- 17. **Supplier Or Dealer** The bidder shall be supplier Or the authorized dealer of the Internet lease line.
- 18. ISP will be required to sign Service Level Agreement having the following:
 - 100 Mbps Internet bandwidth at all the time.
 - Packet Losses: Less than 1% (Average over 1000 ping) at any given point of time to any part of globe.
 - Latency: Less than 350 ms from ISP's to CREST tier 1 peering point.
 - Network Availability: More than 99.5% on RF per month.

2) Qualification Criteria For Bidders:

1. This invitation for bids is open to all firms\ Entrepreneurs who are eligible to do business in India under relevant Indian laws as in force at the time of bidding except those who have been declared by any agency of the Government of Maharashtra to be ineligible to participate for corrupt, fraudulent or any other

- unethical business practices during the period for which such ineligibility is declared.
- 2. Bidder should have installation base of 100 mbps internet leased circuits in Panvel, provide documentary evidence of the same.
- 3. Bidder should have National class A ISP, provide certificate for the same.
- 4. Bidder should have supplied internet bandwidth to in Government office/ Semi govt/ Pvt sector in India should have at least 3 years experience certificate Or should attach work completion certificate Or work order copies in similar nature of work.
- 5. Bidder should have it own fiber backbone with auto switch over.
- 6. Bidder should have GST registration number & should gives scan copy of PAN
- 7. Companies Registration Certificate or valid license from competent authiroty.

If bidder does not submit above certificate their tender will not be considered for further process and will be rejected out rightly.

3) Condition of Contract for Vendor

The Bidder shall furnish following as part of its bid

- 1. Contractor will have to commission the lease line (Internet) within 7 day from the date of issuing the work order.
- 2. The rates quoted should be separately of GST. No price escalation will be allowed due to any reason. The offer should be firm without any uncertain liability. PMC reserves right to open single tender if only single tender qualifies for opening tender.
- 3. The bidder is requested to go through the tender document before filling the tender.
- 4. The bidder who already providing the ILL to PMC in running status should not fill this tender.
- 5. Rates should be quoted in words and figures.
- 6. It is mandatory for bidder to maintain 99.5% uptime with clean bandwidth if lease line will be down for more than 3 hours in a day, then penalty of rupees 500/- per day will be charged & which will be directly deducted from bill without quoting any reason.
- 7. Bidder should provide WAN IP pool & public IP for PMC functionality & should integrate the all functionality & activity regarding internet connectivity. Bidder should resolve the all issue within the time limit.
- 8. If the bidder withdraws his tender before the date of letter informing him about the acceptance of the bidder or the bidder backs out from the work after executing agreement and issue of work order, his earnest money deposit will be forfeited.

- 9. The decision of Municipal Commissioner, PMC about any matter or dispute about the contract will be final and binding on the bidder as well as PMC.
- 10. Any compensation or sums payable by the bidder to the PMC, under the terms of this contract will be deducted from his bill/security deposit.
- 11. No tender will be considered unless submitted in the prescribed form.
- 12. Conditional tender will not be considered.
- 13. Price escalation will be not being admissible on any account whatsoever.
- 14. PMC reserves the right to terminate the contract any time during execution period if the performance or progress of the work is not found satisfactory.
- 15. If the contractor fails to complete the work in given time, PMC may terminate his contract after giving him opportunity.
- 16. Conditional tender will be rejected out rightly.
- 17. MUX has to be installed within PMC premises.
- 18. Dedicated internet bandwidth has to be provided by the bidders.
- 19. Bandwidth supplied should be in loop to ensure redundancy and maximum uptime.
- 20. Bidder should provide minimum 8 live IP's or more as per PMC's requirement for online applications.

4) Earnest Money Deposit. (EMD)

The Bidder has to make Earnest Money Deposit payment through Online method viz Debit card, Credit card, Wallet or Net banking. After successful submission of EMD, bidder should attach the scan copy of EMD receipt in their technical bid document.

Panvel Municipal Corporation reserves the right to reject any or all tenders without assigning any reason. PMC also reserves the right to accept the tender in part or distribute the tender amount to the number of contractors. If contractor refuses to carry out the work on the ground that his tender has not been accepted in full, his earnest money deposit will be forfeited and he will be responsible for any loss on account of such refusal.

The EMD amount for this bid is Rs.10,000/-

Unsuccessful bidders EARNEST MONEY DEPOSIT will be discharged/ refunded online after completion PMC procedure for the said bid.

The successful bidders EARNEST MONEY DEPOSIT will be discharged/ refunded online only after the completion of the contract papers and on submission of Performance Guarantee.

5) Period of Validity of Bids

Bids shall be valid for 120 days after the date of bid opening. Bid valid for a shorter period shall be rejected by the Tendering Authority may solicit the Bidders consent to an extension of the period of validity. The request and the responses thereto shall be made in writing.

Bid evaluation will be based on the bid prices without taking into consideration the above changes.

6) Period of contract

The period of contract will be for 3 (Three) year.

7) Payment terms-

Quarterly payment will be released.

8) Contents of Envelopes

Tender is Two Envelope method. The envelope 'A' Contains all technical document. The envelope 'B' contains all commercial documents.

a) Technical Envelope- Bidder should attached scan copy of following document

- 1. Receipt of Online submission of Earnest Money Deposit.
- 2. PAN Card
- 3. Companies Registration Certificate or valid license from competent authority.
- 4. GST registration certificate.
- 5. Authenticate document proof of work experience in internet lease line service Providing in Government or Semi government.
- 6. Last 3 year IT return & Turnover.

b) Commercial Bid

- 1. Commercial bid will be filled according to attached sheet.
- 2. Bidder must submit Commercial bid with original cost of ILL for year. GST separately mentioned (if applicable).

Bidder should write full name of the work on top of the envelope and shall write his full address at bottom left hand corner of the envelope and which should reach the office of tender Section, PMC on specified date and time. Offer received after this time and date will not be considered in any case.

9) BID OPENING AND EVALUATION OF BIDS.

c) Technical Evaluation.

- 1. Opening of Bids by "THE TENDERING AUTHORITY, will open all bids.
- 2. If all the documents mentioned for the technical envelope are not enclosed in Technical envelope the tender will be summarily rejected.
- 3. After the opening of technical envelopes the evaluation committee will do the preliminary scrutiny of the tender documents. If all the documents mentioned in the relevant clause are attached the tender document will become eligible for detailed scrutiny. In the detailed all document submitted will be examined in detail to test for the authentically and validity of information submitted.
